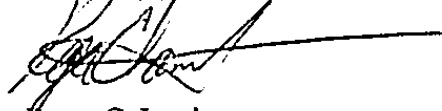

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of this corporation is:

TRUE-VINE CHURCH OF GOD IN CHRIST CHRISTIAN CENTER, INC.

The principal place of business of this corporation shall be 1530 44th Street, West Palm Beach, FL 33407, and the mailing address of the corporation shall be the same.

ARTICLE II.

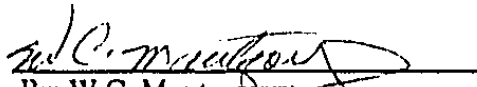

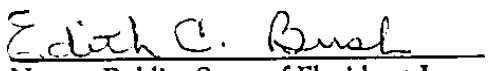
