### ARTICLES OF INCORPORATION

## ASSOCIATED INDUSTRIES OF FLORIDA TRAINING AND EDUCATION -1, PH 2:00 CORPORATION, INC.

(A Florida Not For Profit Corporation)

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I

#### Name

The name of the Corporation shall be Associated Industries of Florida Training and Education Corporation, Inc. (hereinafter referred to as "Corporation").

#### ARTICLE II

#### Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this corporation shall be 516 North Adams Street, Tallahassee, Florida 32301

#### ARTICLE III

#### Nonprofit Purpose

The Corporation is formed exclusively for purposes for which a corporation may be formed under the Florida Not For Profit Corporation Act and not for pecuniary profit or financial gain. No part of the assets, income, or profit of the Corporation shall be distributable to, or inure to the benefit of, its directors, or officers except to the extent permitted under the Florida Not For Profit Corporation Act. Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding provisions of any subsequent federal tax laws.

#### ARTICLE IV

#### <u>Purposes</u>

The purposes for which the Corporation is formed are:

A. Provide a service agency that will be better able to coordinate the community and human services needs of employers and their employees.

- B. Adopt such methods, procedures and policies as may be necessary to accomplish the purpose above set forth consistent with sound policies and standards; and generally to foster cooperative effort and harmonious relationships among community groups of different cultural, economic, religious and social characteristics.
- C. Promote and educate employers and employees and otherwise concern itself within the field of safety and health for the express purpose of enhancing quality of life for working men and women.
- D. Promote and educate employers and employees and otherwise concern itself within the field of employment and training for the express purpose of working with various entities serving economically disadvantaged, dislocated or other persons in need of employment, training or re-training.
- B. Receive and hold real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, scientific, literary or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under § 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.
- F. In furtherance to its corporate purposes, the Corporation shall have all general powers enumerated in the Florida Not For Profit Corporation Act. The Corporation may also pursue any other charitable, scientific, literary or educational activity that may be appropriate within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue law.


