ARTICLE I

NAME

The name of this corporation is GETHSEMANE CHURCH, INC.

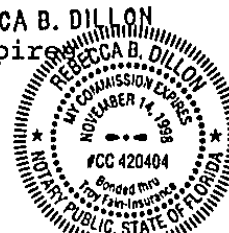

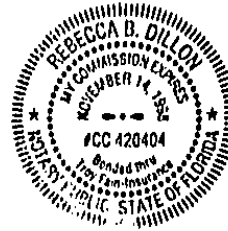
