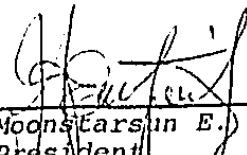

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles Of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: LIGHT FOR THE WORLD MINISTRIES, INC. a Non-Profit Corporation.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

The transacting any and all lawful business permitting under the laws of the State of Florida and to provide a Shelter, food, clothing and medical and other assistance to homeless people.

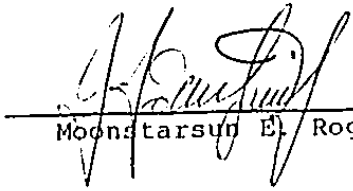

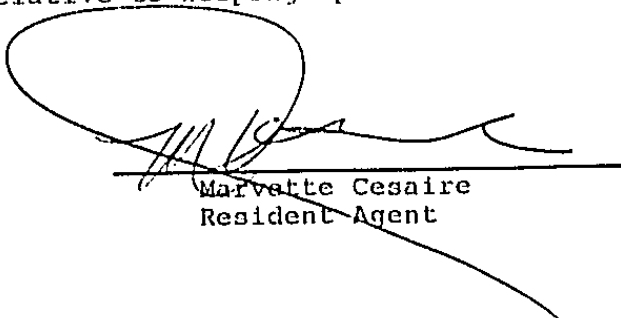
