Articles of Incorporation

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

First - The Name of the corporation shall be "Bible and Life Ministries", Inc.

Second- The place in this state where the principal office of the corporation is to be located is, 16207 Pebblebrook Drive, the City of Tampa, Hillsborough County, 33624.

Third- This Association is organized exclusively for religious and educational purposes. It shall be the purpose of Bible and Life Ministries to provide educational ministries to further knowledge of the Bible. The activities shall include the teaching of the Bible for the spiritual development of believers, through the formation of classes and the publication of the "Bible & Life Newsletter", and the receiving of donations with which to further the teaching of the doctrines and practice of the Bible.

Fourth- The board of directors shall consist of Christians whose lives are consistent with the teaching of the Bible. They shall receive this position by appointment and is perpetual, however this individual may be terminated or replaced if a spiritual reason warrants. This body shall be recognized as the leadership of the spiritual and business functions of the ministry. Meetings shall be held at least semi-annually. The business of the Ministry shall be determined by the board of directors. The business shall be accomplished as directed by the board of directors.

Fifth- No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the third article hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for on or more exempt purposes with the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Sixth- The street address of the corporation's initial registered office is 16207 Pebblebrook Drive, Tampa, FL 33624 and the name of its initial registered agent at this office is David Dunlap.
