ARTICLES OF INCORPORATION

The undersigned, acting as incorporator (s) of a corporation, pursuant to chapter 617, Florida Statutes, adopt (s) the following articles of Incorporation

ARTICLE I

Name

The name of the corporation shall be:
EGLISE DE DIEU L'HOPITAL PAR LA FOI, INC.
(CHURCH OF GOD HOSPITAL BY FAITH)

ARTICLE II

Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III

The specific purpose (s) for which the corporation is organized is (are)

Our objectives are to evangelize, train people to receive the Lord Jesus Christ as the personel savior.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The directors will be appointed by the President of the organization.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida STATUTES, unless limited as follows:

Section 2. The regular meeting on the second Monday in April shall be known as the annual meeting and shall be for the purpose of electing assigned officers, receiving reports of officers and committees, and for any other business that may arise such as programs extension.

Section 3. Special meetings can be called by the president or by the executive board and shall call upon the written request of the members of the organization. The purpose of the meeting shall be stated in the written invitation. Except in cases of emergency, at least three days notice shall be given.

ARTICLE VI

Executive Board

Section 1. The officers of the organization, including the Directors, shall constitute the Executive Board.

Section 2. The Executive Board shall have general supervision of the affairs of the organization between its business meetings, fix the hour and place of meetings, make recommendations to the organization, and shall perform such other duties as are specified to these bylaws. The Board shall be subject to the orders of the organization, and none of its acts shall conflict with action taken by the organization.

Section 3. Unless otherwise ordered by the Board, regular meetings of the Executive Board shall be held on the first Monday of each month from April to March inclusive. Special meetings of the Board can be called by the President and shall be called upon the written request of three members of the Board.

ARTICLE VII

Committees

Section 1. A Finance Committee composed of the Treasurer and three other members shall be appointed by the President promptly after each annual meeting. To assure a balance of power the finance committee will work closely with the Executive Board for spending accuracy. The financial record book shall always be available for verification by sponsors upon request. Any suspicious misused of funds by any member of the organization shall be considered as serious criminal misconduct, the Executive Board shall convene within twenty-four hours to investigate and take any necessary action.

Section 2. An Auditing Committee of three members shall be appointed by the President at the organization's October meeting, whose duty it shall be to audit the Treasurer's accounts at the close of the fiscal year and to report at the annual meeting.
