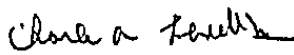

**ARTICLES OF INCORPORATION OF  
POINTS OF LIFE, INCORPORATED  
(A NOT FOR PROFIT CORPORATION)**

The undersigned, for the purpose of forming a non-profit corporation under Florida Statute Chapters 617, do hereby make and adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the Corporation is Points of Life, Incorporated.

**ARTICLE II**

The duration of the Corporation is perpetual.

**ARTICLE III**

The Corporation is a Non-Profit Corporation under the laws of the state of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of the members, directors, or officers, except to the extent permissible under law.

**ARTICLE IV**

The Corporation is organized, and shall be operated exclusively for, the early detection of ovarian cancer and ultimately a cure.

**ARTICLE V**

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance for the purposes as set forth in Article IV hereof.

**ARTICLE VI**

The Corporation shall have voting members who shall be elected (and may be removed) by the voting members and shall have all the rights and privileges as the members of the Corporation. The bylaws may provide for non-voting members of one or more classes who shall be admitted in such manner and who shall have the rights and privileges as are set forth in the bylaws, but who shall not have the right to vote. #### ARTICLE VII

##### PRINCIPAL OFFICE

The street address of the initial registered agent of the Corporation is 1108 Jasmine Ave., Fort Pierce, FL 34982, and the name of its initial registered agent at that address is Vonda Lee Dixon.

#### ARTICLE VIII

The management of the Corporation shall be vested in the Board of Directors. The number of Directors constituting the initial Board of Directors is three. The number of Directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than three. The voting members shall elect the Directors annually. The name and address of each individual Director for the Corporation is as follows:

#### ARTICLE IX

The Officers of the Corporation shall consist of a President, Secretary, Treasurer, and such other officers and assistant officers as may be provided in the bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) as such time and such manner as may be prescribed by the bylaws. The bylaws of the Corporation are to be made and adopted by the Board of Directors, and may be altered, amended or rescinded by the Board of Directors

## ARTICLE XII

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Corporation or any amendment to them, and all rights and privileges conferred upon the members, directors, and officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the state of Florida, as amended from time to time, unless more specific provisions or amendments are adopted by the Corporation pursuant to law.

## ARTICLE XIII

This Corporation is organized on a nonstock basis. The Corporation shall not issue shares of stock.

## ARTICLE XIV

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations describe in Section 501 (c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

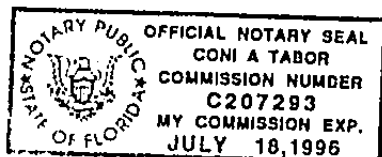
