**CERTIFICATE OF INCORPORATION**

**TAMPA BAY FAMILY BUSINESS FORUM, INC.**

We, the undersigned hereby adopt and declare the following as the Certificate of Incorporation for **TAMPA BAY FAMILY BUSINESS FORUM, INC.**, a non-profit Florida corporation. The Articles of Incorporation are as follows:

**ARTICLE ONE. NAME**

The name of this corporation is **TAMPA BAY FAMILY BUSINESS FORUM, INC.**

**ARTICLE TWO. STATEMENT OF PURPOSE**

This is a non-profit corporation organized solely for educational and general charitable purposes pursuant to the Florida Corporation Not for Profit law set forth in Part I of Chapter 617 of the Florida Statutes, and for such purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws including for such purposes, the making of distributions to organizations which qualify as tax exempt corporations under that Code.

**ARTICLE THREE. TERM**

This corporation shall have a perpetual existence.

**ARTICLE FOUR. LOCATION OF PRINCIPAL OFFICE  
AND IDENTIFICATION OF REGISTERED AGENT**

(a) The county in the State of Florida where the principal office for the transaction of the business of this corporation is to be located is the County of Pinellas, 101 Starcrest Drive, Clearwater, Florida 34625.

(b) The name and address of the corporation's registered agent is st Jill Fisher Powers at 877 Executive Center Drive, Suite 303, St. Petersburg, Florida 33702, the corporation's registered office.

**ARTICLE FIVE. MANAGEMENT OF CORPORATE AFFAIRS**

The powers of this corporation shall be exercised, its properties controlled, and its legal

and business affairs conducted by a board of directors. The board of directors shall be elected as set forth in the bylaws of the corporation.

#### ARTICLE SIX. INCORPORATORS

#### ARTICLE SEVEN. DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to educational and charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof.

#### ARTICLE EIGHT. DISTRIBUTION OF ASSETS

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for educational or charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

#### ARTICLE NINE. AMENDMENT OF ARTICLES

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of members for their vote. Amendments may be adopted by the vote of two-thirds of a quorum of members of the corporation.




