Articles of Incorporation of Latin American Marketing Association, Inc.

Article I. Name

The name of this Florida not-for-profit corporation is Latin American Marketing Association, Inc.

Article II. Address

The mailing address of the Corporation is:

Article III. Purpose

The Corporation is organized as a trade association for establishing standards and measurements for marketing products and services in Latin America and the Caribbean and to engage in all other lawful acts or activities not for pecuniary profit for which Florida not-for-profit corporations may be organized.

Article IV. Membership

All persons interested in the purposes of the Corporation are eligible for membership in the Corporation if they are capable of contributing to the achievement of those purposes and the effective operation of the Corporation, and if they comply with the requirements established from time to time in the Bylaws. Members shall have no voting rights or other rights except as provided in the Bylaws. The Corporation shall have two classes of members: founding members and associate members.

Article V. Registered Agent

Article VI. Limitations

No part of the net earnings of the Corporation shall inure to the benefit of (or be distributable to) its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes.

Article VII. Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three directors. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but may never be less than three. The election of directors shall be done in accordance with the Bylaws. The directors shall be protected from personal liability to the fullest extent permitted by law. Article X. Corporate Existence
