ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of the corporation is LAKE MYSTIC NEIGHBORHOOD ASSOCIATION, INC., and the initial principal address of the corporation is Rt. 1, Box 241S, Bristol, Florida 32321.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

This organization is organized exclusively for educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

The specific purpose of LAKE MYSTIC NEIGHBORHOOD ASSOCIATION, INC. is educational, providing a vehicle for the promotion and dissemination of information concerning

pollution prevention, water safety, neighborhood crime watch, and pedestrian friendly roads, for the common good of LAKE MYSTIC and the LAKE MYSTIC neighborhood. Activities shall include-but not be limited to-a newsletter and an annual "Know Your Neighbor Barbeque."

ARTICLE IV

The qualifications for members and the manner of their admission are set forth in the bylaws of the corporation

ARTICLE V

The street address and city fo the initial registered office is Rt. 1, Box 241S, Bristol, Florida 32321, located in Liberty County, and the name of its initial registered agent at such address is Barbara Singletary.

ARTICLE VI

The number of directors constituting the initial Board of Director of the corporaton is nine (9) and the names and addresses of the persons who are to serve as the initial directors are: (The manner of election of Directors is set forth in the Bylaws of the corporation.)
