The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is Prevention Unlimited, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 3332 N. Key Drive , Unit G-1, North Ft. Myers, FL 33903.

ARTICLE III: PURPOSE

Specific nature of business is Substance Abuse Prevention.

ARTICLE X: AMENDMENTS


The corporation reserve the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
