The undersigned, for the purpose of forming a corporation not for profit under the laws of Florida, adopt the following Articles of Incorporation.

ARTICLE I

Section 1.1 - Name The name of this corporation shall be the Ruskin Place Artists' Guild, Inc.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

Section 2,1 - Principal Office and Mailing Address. The address of the principal office of this Corporation shall be 210 Ruskin Place, Senside, FL. The mailing address is P.O. Box 4908, Santa Rosa Beach, FL 32459.

ARTICLE III MEMBERS

Section 3.1 - Members. This Corporation shall have members. The qualifications for, manner of admission of, and voting and other rights of members shall be set forth in the Bylaws of the Corporation.

ARTICLE VI DURATION

Section 6.1 - Duration. This Corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed with the Department of State of the State of Florida within five (5) days after they are executed, corporate existence shall commence upon filing with the Department of State.

ARTICLE VII PURPOSE AND POWERS OF THE CORPORATION
