ARTICLES OF INCORPORATION OF NORTH COUNTY NEIGHBORHOOD ASSOCIATION OF MANATEL COUNTY INCORPORATED (A FLORIDA NONPROFIT CORPORATION)

ARTICLE L NAME

The name of this corporation shall be North County Neighborhood Association of Manatee County, Incorporated (Inc.).

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department of State. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

The North County Neighborhood Association of Manatee County, Inc., being broadly representative of the community consisting of census 15.01 and 15.02, seeks to work for the betterment of the community by facilitating communication with residents ascending needs and promoting programs to meet those needs in the areas of neighborhood revitalization, economic development, housing, education, day care, recreation, health and law enforcement.

ARTICLE IV. POWERS

This corporation may do and perform all such acts and things, including those generally allowed by the laws of Florida relative to corporations not for profit, as now existing, or as the law may henceforth provide, as for time to time may be necessary or expedient to the exercise of any and all of its corporate functions, powers, and rights.

ARTICLE V. MEMBERSHIP

Any resident or organization residing in Manatee County, and who agrees to be bound by these Articles of Incorporation, which the Board of Directors may from time to time adopt, who completes a membership application form and submits it to the Board of Directors, and also pays the applicable dues, is eligible and qualified for membership in this corporation.

The corporate Bylaws may provide the Board of Directors further discretionary powers relating to the admission of members.

ARTICLE VI. EARNING AND DISTRIBUTIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, Trustees, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation and for services rendered and to make payments in furtherance of purposes set forth herein. No loans or royalties shall be paid to fiduciaries nor shall any private personal use of any corporate asset be permitted. No fiduciary may vote on or set on or participate in deliberations regarding his own salary or that of a family member whenever feasible. No substantial part of the activities of the corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign of behalf of nay candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by an organization, contributions Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE VII. MANAGEMENT

The powers of this corporation shall be exercised, its properties controlled, and its affairs and business conducted and managed by the Board of Directors.

Any action required or permitted to be taken by the Board of Directors, under any provision of the law, may be taken without a meeting, if all of the directors shall individually or collectively consent in writing to such action. Such written consent shall have the same force and effect as if taken by unanimous vote of the Board of Directors. Any certificate or other document filed, under any provision of the law which relates to the action so taken, shall state that the action was taken by the unanimous written consent of the Board of Directors without a meeting, and that these Articles of incorporation authorize the Board of Directors to so act. Such a statement shall be prima facia evidence of such authority.

ARTICLE VIII. BOARD OF DIRECTORS

This corporation's initial Board of Directors shall have nine(9) directors. The number of directors may be increased or decreased, from time to time, by an amendment to the corporate Bylaws, but shall never be less than nine(9).

The directors shall be elected annually by this corporation's members. The manner of the election of the directors shall be specified in the corporate Bylaws.
