# ARTICLES OF INCORPORATION OF

THE ST. GEORGE ISLAND YACHT CLUB
(A Corporation not for Profit)

THE UNDERSIGNED subscribers to these Articles of Incorporation hereby propose the incorporation under Chapter 617, Florida Statutes, of a corporation not for profit and have to that purpose made, subscribed, acknowledged and filed with the Secretary of State of the State of Florida such Articles of Incorporation, and respectfully request approval thereof, setting forth hereafter all information required by statute:

#### **ARTICLE 1**

#### Name

The name of this corporation shall be ST. GEORGE ISLAND YACHT CLUB, INC.

## ARTICLE II Principal Office

The principal office for the transaction of affairs shall be 312 Gander St. George Island, Florida 32328.

# ARTICLE III Purpose

#### A. General:

The general nature of the objects and purpose of this corporation shall be to:

- 1. organize pleasure and recreational outings for members:
- 2. promote boating safety:
- 3. to promote community spirit by participation in community events, and
- 4. to do all acts and things and carry on and conduct all other activities necessary, suitable, convenient, useful or expedient in connection with or incidental to the accomplishment of any of the purposes set forth herein to the full extent permitted by the laws of the State of Florida.

#### B. Restrictions:

Notwithstanding any other provision in these Articles, all activities of the corporation shall be carried on and all of the funds of the corporation, whether income or principal and whether acquired by gift, contribution or otherwise, shall be used and applied exclusively for charitable, scientific, literary or educational purposes, and so that no part of the net earnings of the corporation will in any event inure to the personal benefit of any member, officer or trustee of the corporation or to any organization or individual; provided, however, that a reasonable compensation may be paid to any member, officer or trustee of the corporation in exchange for services actually rendered to or for the benefit of the corporation in furtherance of one or more of its purposes stated above, and further that organizations and individuals may benefit from grants, scholarships, fellowships and similar payments or

contributions made for a charitable, scientific, literary or educational purpose and in furtherance of the objects and purposes of the corporation.

The corporation shall not engage, otherwise than as an insubstantial part of its total activities, in activities which in themselves are not in furtherance of one or more of the exempt purposes specified in section 501(c)(7) of the Internal Revenue Code of 1995, as amended; and no part of the organization's net earnings will inure to the benefit of any person having a personal and private interest in the activities of the organization.

# ARTICLE IV Directors/Officers

#### A. Officers:

The affairs of the corporation shall be managed by its officers. The officers of the corporation shall include a Commodore, Vice Commodore, Purser and Yoeman, and no individual may hold at the same time more than one office, other than the offices of Purser and Yoeman. Directors shall be elected as stated in the by laws.

#### B. Elections:

Officers of the corporation shall be elected by a majority of votes cast at any duly constituted membership meeting, and shall serve in the positions to which they have been elected in accordance with applicable provisions of the by-laws.

#### C. <u>Vacancies and Removal</u>:

A vacancy in any elective position cased by the death, resignation, removal or other disqualification of the holder shall be filled in accordance with applicable provisions of the by-laws.

#### D. <u>Additional Offices</u>:

At any annual meeting of the membership of the corporation such additional offices as may be necessary, in the judgment of a majority of the voting members present at such meeting, may be created and individuals elected thereto in the manner, for the term and subject to the conditions of other corporate offices herein established. Each such additional officer of the corporation shall automatically become a member of the corporation's management.

## ARTICLE V Limitation of Corporate Powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

Distribution Upon Liquidation or Dissolution

Upon dissolution of this corporation, or the complete liquidation of its assets, whether voluntary or involuntary or by operation of law, except as and to the extent otherwise provided or required by law, the net assets remaining after payment of all debts and obligations of the corporation and of all costs and expenses of such liquidation or dissolution, shall, by action of the membership taken at a special meeting called for that purpose, be distributed to an organization which shall have qualified for a federal income tax exemption, or to the federal or a state or local government, subject always to the provisions of Section B., Article II of these Articles and to the specific condition that none of the net assets of the corporation shall be distributed to or for the benefit of any member, officer or trustee of the corporation or to any other individual; provided, however, that nothing contained in this article shall be construed to prevent a distribution from the net assets of the corporation to another distributee, otherwise properly made in accordance with the provisions of these articles and the purpose herein stated, solely by reason of the fact that one or more of the
