ARTICLES OF INCORPORATION

OF

NORTHSIDE MISSIONARY BAPTIST CHURCH OF LAKELAND, FLORIDA, INC.

(A Corporation Not for Profit)

We, the undersigned incorporators, all being of legal age and competent to contract, do hereby associate together for the purpose of organizing a corporation not for profit under the laws of the State of Florida, and do hereby make, subscribe, acknowledge, and file these Articles of Incorporation.

ARTICLE I

The name of this corporation is: Northside Missionary Baptist Church of Lakeland, Florida, Inc.

ARTICLE II

The general nature of the object of this corporation is to conduct for religious worship and instruction churches, schools, pastorians, and other institutions

connected therewith of a religious, educational, charitable, and benevolent character to the end that the corporation shall carry out the great commission of our Lord, Jesus Christ, as it is recorded in Matthew 28:19-20, Mark 16:15, Acts 1:8, and to develop Christian fellowship and growth in the knowledge of our Lord, Jesus Christ among the saints.

ARTICLE III

Every person who believes in repentance toward God, and faith in Jesus Christ, as Savior and Lord, and who is willing to confess Him publicly as Lord and King, and to follow Him in baptism by immersion, and to observe the ordinances of Christ and to be governed by His laws, is qualified and eligible for membership in said corporation.
