ARTICLES OF INCORPORATION  
OF  
NORTHSIDE MISSIONARY BAPTIST CHURCH OF LAKE LAND, FLORIDA,  
INC.  
(A Corporation Not for Profit)

We, the undersigned incorporators, all being of legal age and competent to contract, do hereby associate together for the purpose of organizing a corporation not for profit under the laws of the State of Florida, and do hereby make, subscribe, acknowledge, and file these Articles of Incorporation.

ARTICLE I

The name of this corporation is: Northside Missionary Baptist Church of Lakeland, Florida, Inc.

ARTICLE II

The general nature of the object of this corporation is to conduct for religious worship and instruction churches, schools, pastorians, and other institutions

connected therewith of a religious, educational, charitable, and benevolent character to the end that the corporation shall carry out the great commission of our Lord, Jesus Christ, as it is recorded in Matthew 28:19-20, Mark 16:15, Acts 1:8, and to develop Christian fellowship and growth in the knowledge of our Lord, Jesus Christ among the saints.

### ARTICLE III

Every person who believes in repentance toward God, and faith in Jesus Christ, as Savior and Lord, and who is willing to confess Him publicly as Lord and King, and to follow Him in baptism by immersion, and to observe the ordinances of Christ and to be governed by His laws, is qualified and eligible for membership in said corporation. The manner of admission in said corporation shall be by letter of recommendation from other churches of like faith and order, and by profession of faith as hereinbefore provided and for baptism according to the policies of said corporation, upon a favorable majority vote of the membership of said corporation present at any meeting of said Church. The present membership of Northside Missionary Baptist Church of Lakeland, Florida (unincorporated) and those hereafter admitted to such membership shall constitute the membership of this corporation.

#### ARTICLE IV

The corporation shall have perpetual existence unless sooner dissolved according to law.

#### ARTICLE V

The business affairs of this corporation shall be managed by a board of directors, such management to be subject to the approval of the church composed of not less than three and said board of directors shall be elected from and by the membership of said corporation. By virtue of his office, the Pastor and every succeeding pastor shall be President. In addition, the membership of said corporation shall elect the following officers: Vice-president, secretary, and treasurer, who shall be members of the board of directors. All legal instruments of the corporation shall be signed by the president or vice-president, sealed with the corporate seal, and attested by the secretary, or in such manner as may be authorized by the By-laws of the corporation. The terms of the board of directors and of the officers shall be as provided by the By-laws of the corporation.

## ARTICLE VI

The names and post offices of the officers and directors, who subject to the By-laws and these Articles of Incorporation shall hold office until their successors are duly elected and qualified, shall be:

## ARTICLE VIII

The original By-Laws of this corporation shall be made and adopted by the Members by a majority vote thereof. Thereafter the Articles of Incorporation may be amended and the By-laws may be amended, changed, repealed, or enlarged by the Members of the Corporation by a majority vote of the Members present at any regular business meeting of the corporation, or at any special meeting called for that purpose as provided by the By-laws of the corporation.
