# ARTICLES OF INCORPORATION

OF

# STEVE SCHEFFLER MINISTRIES, INC.

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

#### ARTICLE I

The name of the corporation shall be Steve Scheffler Ministries, Inc., and the proposed place of business shall be 209 West Pineloch Ave., Orlando, FL 32806.

#### ARTICLE II

The period of the duration of this corporation shall be perpetual, unless dissolved according to law.

#### ARTICLE III

- A. The purposes for which New Harvest Outreach Center, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
