ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

To encourage the maintenance, preservation, reconstruction and safety of the early dignity, beauty and heritage of the Seville Historic District by doing all such acts as may be necessary to stimulate interest in the local history and landmarks of said district.

It is organized to operate exclusively to promote the health, safety, and general economic and social welfare so as to qualify it as a tax exempt organization under Section 501 (c) (3/4) of the Internal Revenue Code of 1954, or the corresponding provisions of any subsequent federal tax laws. The Board is not organized for and shall not be operated for profit.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The original board of directors shall be formed by the submission of names to the trustees of the Historic Pensacola Preservation Board. The trustees shall appoint the members from the list. Thereafter, all board members shall be elected by the members.
