ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be: The Artist Preview Association, Inc.

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

Purpose(s)

The specific purposes for which the corporation is organized are:

1. To provide learning opportunities in the arts of music, acting, dance, painting and other art forms, to underprivileged and inexperienced persons, as well as hobbyists, in the Tampa Bay community. Such learning opportunities will be offered initially through the use of talented volunteers.
2. To develop opportunities for underprivileged and inexperienced persons, and hobbyists to present public entertainment and promote community interest in the arts through a full spectrum of events
3. The Artist Preview Association qualifies as a not for profit organization under the provisions of Section 501 (c) (3) of the United States Internal Revenue Code.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as stated in the bylaws of the corporation. The incorporators named in these articles, and other interested individuals, shall serve as the interim officers and directors of the corporation until the first general membership meeting, at which time elections of officers and directors shall be conducted.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, and are not limited.


