ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 817, Florida Statues, adopt(s) the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation shall be:

ARTICLE III

The specific purpose(s) for which the corporation is organized is (are)

- (1) To serve our country in peace as in war; to build and maintain the welfare of the United States of America towards lasting prosperity and peace for all its inhabitants.
- (2) To encourage, in keeping with policies of our government, the establishment of a concrete plan to secure permanent international peace and to assist in the maintenance of international peace.
- (3) To inspire in our membership a sense of responsibility and to develop leadership for the preservation of our American democratic way of life.
- (4) To help unify divergent groups in the overall interest of American democracy.
- (5) To train our youth to become purposeful citizens in a democracy with full knowledge of the responsibilities as well as the privileges of citizenship.
- (6) To cooperate with all duly recognized veterans organizations in the furtherance of the aim of the veterans of World War II, Korea, Vietnam and those serving in the Armed Forces of the United States thereafter.
- (7) To ensure the orderly return of the veteran to civilian life by protecting his rights as an individual while he is still in uniform.
- (8) To expedite and assist in the rehabilitation of veterans by maintaining employment services; sponsoring educational opportunities; providing counsel on insurance, housing, recreation, personal problems, hospitalization and veterans benefits.
- (9) To act as a liaison agent between the veteran and the government.
- (10) To provide an organization to encourage fellowship among all veterans of World

War II, Korea, Vietnam and those serving in the Armed Forces of the United States thereafter.

(11) To keep the public forever reminded that the veterans of World War II, Korea, Vietnam and those serving in the Armed Forces of the United States thereafter fought and served to preserve peace, liberty and democracy for their nation.

(12) To take by gift, devise, purchase or in any manner whatsoever, real and personal property, and to sell, transfer, mortgage, lease or rent in any manner whatsoever, the same, and to do all things necessary and essential thereto for the benefit of the Corporation.

(13) To do all things necessary and essential to carry on the activities, rehabilitation, welfare and social work of the post, including the establishment and operation of club rooms and other financial operation for the purpose of obtaining the net profits therefrom for the use and purpose of the post.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows:

(1) Officers of this post shall consist of a Commander, not more than three Vice Commanders, Adjutant, Finance Officer, Provost Marshall, Judge Advocate, three Trustees and such other officers as may be prescribed by the By-Laws.

(2) Nominations and elections of officers shall be held annually at a date fixed by the By-Laws. Nominations shall be made from the floor at a general membership meeting.

ARTICLE V

The corporate powers of this corporation are as provided in section 817.0302, Florida Statutes unless limited are as follows:

(1) This corporation shall have a perpetual existence, subject to the Laws and provisions of the State of Florida and the constitution and By-Laws of the American Veterans of World War II, Korea, Vietnam and those serving in the Armed Forces of the United States thereafter.


ARTICLE VI


