ARTICLES OF INCORPORATION
OF

SHERIFF'S HISPANIC ADVISORY COUNCIL INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: SHERIFF'S HISPANIC ADVISORY COUNCIL INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 3124 Tampa Bay Blvd, Tampa, Florida 33607-6614.

ARTICLE III

The specific purposes for which the corporation is organized are:

1. Reflecting on issues that impact on the Hispanic community.
2. To afford the Sheriff's Office their understanding of matters of concern to the community or to individuals within the community.
3. To communicate to the community information regarding the Sheriff's Office which will serve to enlighten them as to the Sheriff's Office philosophy, procedures, management and activities.
4. To serve as a conduit for the exchange of information through which the public and the Sheriff's Office can arrive at an understanding of each other's concerns.

ARTICLE IV

All the Directors shall be elected every year. The method of election of directors shall be regulated by the bylaws. Until new election is held, the following persons shall serve as corporate officers:
