The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: SHERIFF'S HISPANIC ADVISORY COUNCIL INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 3124 Tampa Bay Blvd, Tampa, Florida 33607-6614.

ARTICLE III
