ARTICLES OF INCORPORATION  
OF

LIFE UNIVERSITY, INC.  
(A Corporation Not For Profit)

The undersigned, acting as Incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of this Corporation shall be LIFE UNIVERSITY, INC. Its principal office shall be located at 15500 49th Street N., Clearwater, Florida 34622

ARTICLE II

The period of duration of this Corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing of the Articles of Incorporation with the Secretary of State, State of Florida.

ARTICLE III

The purpose or purposes for which the Corporation is organized is as follows:

Section 1. The exempt purpose of this Corporation shall be to support worship of the Almighty God and strengthen each individual's seeking to know the pathway to eternal progression and expansion of peace, love, unity, and brotherhood. This shall be accomplished giving instruction, lectures and education in all phases of Religion, Philosophy, Spiritualism, Metaphysics and Environmental Protection.

The Corporation shall propagate the scientific rationale for the teachings of God and shall support Holistic Health by providing healing services, classes, counseling, prayers and protection of our environment. The Corporation shall investigate all phases of psychic phenomenon, including home study and demonstrations; inspire through spirit communication the practice of pure spiritualism by healing, lecturing, mediumship, prophecy, music, meditation, prayers, and environmental protection; and will strive for the truths incorporated in our principles, teaching that the highest morality is contained in the Golden Rule.

Section 2. The Corporation shall be empowered to establish teaching centers to train ministers, teaching healing, workers, missionaries, children, to ordain ministers, and conferring degrees as set forth in the By-laws of this Corporation.

Section 3. The Corporation shall be empowered to publish papers, pamphlets, books and magazines, acquire, rent, lease, let, hold, own, buy, convey, mortgage, sell, or assign property, real and personal or mixed, as the purpose of this Corporation, whether express or implied, shall require.

Section 4. The Corporation shall be empowered to do and perform all such other acts and things, including those generally allowed by the laws of the State of Florida relative to Corporations not for profit, as now existing, or as the law may henceforth provide, as from time to time may be necessary or expedient in the exercise of any or all of its corporate functions, powers and rights.

#### ARTICLE IV

The membership of this Corporation shall constitute all persons who shall share in the aspirations, objects and purposes of the corporation as stated in Article III, Section I, and whose application for membership shall be approved by a majority of the Board of Directors.

#### ARTICLE V

The street address of the initial registered office of this Corporation in the State of Florida, shall be 15500 49th Street N., Clearwater, Florida 34622. The name of the initial registered agent of the corporation at the registered office shall be REV. ELMER R. WOOD.

#### ARTICLE VI

The number of directors constituting the initial Board of Directors of the Corporation is Three (3). The manner in which directors are elected may be as stated in the By-Laws.

#### ARTICLE VII

This Corporation is organized under a non-stock basis.

ARTICLE VIII

In the event of dissolution, the residual assets of organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c) (3) and 170(c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or local government for exclusive public purpose.
