## HIGHLIGHTING HILLSBOROUGH, INC. A FLORIDA NONPROFIT CORPORATION

#### ARTICLE 1

#### Name and Address

The name of the corporation is: Highlighting Hillsborough, Inc. The principal and registered office address of the corporation is 3715 Casaba Loop, Vairico, Florida 33594.

#### ARTICLE 2

#### **Duration**

The duration of the Corporation is perpetual.

#### ARTICLE 3

#### THE PURPOSE FOR THE INCORPORATION

The Purposes of the Corporation are:

- 1. To organize and fund the program to paint and rehabilitate the homes of low income and elderly residents who fall at or below the minimum poverty level in Hillsborough County, Florida.
- 2. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

3. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Pederal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

#### ARTICLE 4

#### **Members**

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Non-voting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. #### ARTICLE 5

#### **Initial Registered Agent and Office**

The initial registered agent is Fred Uphoff and the initial registered office is 3715 Casaba Loop, Valrico, FL 33594.

#### **ARTICLE 6**

#### Initial Board of Directors

The initial Board of Directors shall have three members whose names and addresses are:

The number of directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three. The number of directors may be increased or decreased from time to time by vote of the Shareholders and the directors shall be elected as set out in the bylaws.

#### ARTICLE 7

#### **Officers**

The officers of the Corporation shall consist of a President, Secretary and Treasurer. Other officers may be provided for in the Bylaws. Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. #### ARTICLE 8

#### **INCORPORATOR**

#### Nonstock Basis

The corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the Bylaws.

#### ARTICLE X

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the organization is then located, exclusively for such purposes.
