ARTICLES OF INCORPORATION OF
BLOUNTSTOWN CHURCH OF CHRIST, INC.

A FLORIDA CORPORATION NOT FOR PROFIT

ARTICLE ONE
NAME AND ADDRESS

The name of this corporation is BLOUNTSTOWN CHURCH OF CHRIST, INC. Principal office shall be 277 Shuman Ferry Road, Altha, FL 32421 and the mailing address shall be the same.

ARTICLE TWO
ENABLING LAW

This corporation is organized pursuant to the Florida Not For Profit Corporation Act.

ARTICLE THREE
PURPOSES

A) The specific and primary purpose for which this corporation is organized is:

i) To incorporate that certain church organization known as the Blountstown Church of Christ.

ii) To provide members of the Blountstown Church of Christ and the general public a place for worship, fellowship, christian education, evangelism and missionary endeavors.

iii) To purchase, lease or otherwise hold ownership of real property to further the purpose set forth in paragraph 1.

B) This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes as set forth in subparagraphs (a) of this article.

ARTICLE FOUR
TERM

This corporation shall have a perpetual existence.

ARTICLE FIVE
INCORPORATORS

The name and residence of the subscribers to these articles of incorporation are as follows:

ARTICLE SIX
NON STOCK CORPORATION

This corporation shall be non-stock, and no dividends or pecuniary profits shall be declared or paid to the members, officers or trustees thereof.

ARTICLE SEVEN
MEMBERSHIP

Classes of membership, qualifications thereof, and grounds for suspension of membership shall be set forth with particularity in the by-laws in the corporation.

ARTICLE EIGHT
MANAGEMENT OF CORPORATE AFFAIRS

a) Board of trustees - The powers of this corporation shall be exercised, its properties controlled and its affairs conducted by a board of not less than 3 trustees. The numbers of trustees herein provided for may be changed by a bylaw duly adopted by the members entitled to vote. The Board of Trustees shall be elected at the first business meeting with the corporation as provided in the corporate by-laws.

The names and addresses of the persons constituting the first board of trustees who are to act in that capacity until the selection of their successors are:

b) Elective officers - The officers of this corporation shall be a President, Vice President, Secretary, and Treasurer. Other officers may be established by members of this corporation at any regular annual meeting. The qualifications, the time and manner of election or appointing, the duties of the terms of office, and the manner of removing offices shall be as set forth in the bylaws.

The officers who are to serve until the first election of officers under the articles of incorporation are:

ARTICLE NINE
REGISTERED AGENT

a) The street address of this corporation's initial registered office in the State of Florida is 277 Shuman Ferry Road, Altha, Florida, 32421.

b) The name of this corporation's initial registered agent at the above address is David Bataman.

ARTICLE TEN
BYLAWS

Bylaws will be hereinafter adopted at the first meeting of the board of trustees. Such bylaws may be amended or repealed in whole or in part by the trustees in the manner provided therein. Any amendments to the bylaws shall be binding on all members of this corporation.

ARTICLE ELEVEN
INCOME

Any income derived through operation of the programs set up to accomplish the purpose for which this corporation was formed, or received through contributions, public fund raising events, or in any other manner, may not be paid which is not tax exempt under Section 501 (c) (3) of the Internal Revenue code.

ARTICLE TWELVE
AMENDMENT OF ARTICLES

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of trustees and presented to a quorum of members for their vote. Amendments may be adopted by a vote of at least two-thirds of a quorum of members of the corporation.

ARTICLE THIRTEEN
DISSOLUTION

This corporation shall be dissolved and its affairs wound up by a three-fourths vote of the corporation's voting members, officers or trustees, when the objects for which the corporation is organized have been fully accomplished.

In the event of dissolution, no property or assets of the corporation shall be distributed to any of its members, officers or trustees.
