ARTICLES OF INCORPORATION

MIKE KRUGER MINISTRIES, INC.

A NON-PROFIT CORPORATION

The undersigned incorporator, in order to form a non-profit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

ARTICLE I:

The name of this corporation is MIKE KRUGER MINISTRIES, INC.

ARTICLE II:

The initial principal place of business of this corporation shall be: 5147 Flicker Field Circle, Sarasota, Florida, 34231, and its initial mailing address shall be: Post Office Box 19291, Sarasota, Florida, 34276

ARTICLE III:

The specific purpose for which this corporation is organized is: to establish a religious organization to promote the teachings of, and publish materials of and concerning, the Christian faith.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV:

The corporation shall have three (3) directors and collectively they shall be known as the Board of Directors. The number of directors may be increased or decreased from time to time by amendment to these bylaws, but at no time will the number of directors be fewer than three (3). The manner in which directors are elected or appointed shall be as set forth in the corporation's bylaws.

**ARTICLE V:**

The corporate powers of the corporation are as provided in Section 617.0302, Florida Statutes.

**ARTICLE VI:**

The name and address of the registered agent of this corporation is:

**ARTICLE VII:**

**ARTICLE VIII:**

The period of duration of this corporation is perpetual.

**ARTICLE IX:**

Any additional provisions for the operation of the corporation are as follows:

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.


No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation 1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; 2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code; 3) shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; 4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and 5) shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.
