

ARTICLES OF INCORPORATION OF AMBASSADORS FOR CHRIST EVANGELISTIC MINISTRIES, INC.

(A Corporation Not for Profit)

ARTICLE II

ADDRESS:

The initial post office address of the principal office of the Corporation in the State of Florida shall be <u>2818 N.E. 54th Street</u>, Gainesville, FL 32609. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

ARTICLE III

PURPOSE:

The specific and primary purposes for which this Corporation is formed are:

- (a) The general nature of the object of this corporation will be to expound and maintain the Holy Bible as the foundation of all spiritual truths through the means of revivals, street services, work shops, youth programs and one-on-one counseling.
