
Pursuant to Section 617.1403, Florida Statutes, this

Section 617.0701 F.S.

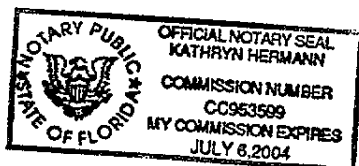


