ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I Name

The name of the corporation shall be:

ARTICLE II

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

TO PROMOTE THE WELFARE OF CHILDREN AND YOUTH IN HOME, SCHOOL, COMMUNITY AND PLACE OF WORSHIP; TO RAISE THE STANDARDS OF HOME LIFE; TO SECURE ADEQUATE LAWS FOR THE CARE AND PROTECTION OF CHILDREN AND YOUTH; TO BRING INTO CLOSER RELATION AND HOME AND THE SCHOOL, THAT PARENTS AND TEACHERS MAY COOPERATE INTELLIGENTLY IN THE EDUCATION OF CHILDREN AND YOUTH; TO DEVELOP BETWEEN EDUCATORS AND THE GENERAL PUBLIC SUCH UNITED EFFORTS AS WILL SECURE FOR ALL CHILDREN AND YOUTH THE HIGHEST ADVANTAGES IN PHYSICAL, MENTAL, SOCIAL, AND SPIRITUAL EDUCATION.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

1) The officers of this assocation shall consist of a president, maximum of 2 vice presidents, a recording secretary, a corresponding secretary, a treasurer.

Director shall be elected by ballot annually in the month of April. However, if there is but one nominee for any office, election for that office may be by show of membership cards or voice vote. A majority vote shall elect.

3) With the exception of the treasurer, officers shall assume their official duties following the end of the school year and shall serve for a term of one year or until their successors are elected. The treasurer shall assume their duties after the books have been audited.

4) A person shall not be eligible to serve more than two consecutive terms in the

same office.
