Name

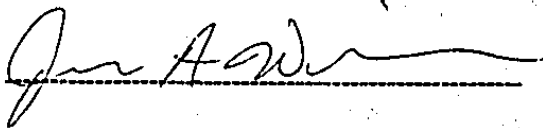
