The undersigned, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of incorporating under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be: Dunnellon Community Organization for Recreation and Prevention, Inc.

ARTICLE II - PURPOSE

The purpose of Dunnellon Community Organization for Recreation and Prevention, Inc. shall be to provide recreational, educational, and creative activities to the youth of the Dunnellon area.

The purposes for which this corporation is organized are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any activity not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law. Upon dissolution of the corporation, its assets shall be distributed for one or more exempt purposes, within the meaning of Section 501(c)(3) of the Internal Revenue

Code of 1986 or corresponding sections of any future United States Internal Revenue law, or shall be distributed to the Federal, State, or local government for public purposes. Any such assets not so disposed of by the Circuit Court in and for Marion County, Florida wherein the principal offices of the corporation are to be located exclusively for a public purpose.

ARTICLE III - STOCK

This corporation shall not have, and shall issue no stock.

ARTICLE IV - TERM OF EXISTENCE

The date when corporate existence shall begin is as of the date these Articles of Incorporation are filed with the Secretary of State of the State of Florida. The corporation shall exist perpetually thereafter unless dissolved by law.

ARTICLE V - ADDRESS OF CORPORATION

The initial street address of the principal office of this corporation in the State of Florida will be 11580 Camp Drive, Dunnellon, Florida 34432. The Board of Directors shall have the power to establish branch offices, and to move the principal office to any other address in Florida.

ARTICLE VI - BOARD OF DIRECTORS

A. The initial number of Directors of this corporation shall be three (3). The number of Directors may be increased or diminished from time to time by By-laws adopted by the stockholders, but shall never be less than three (3). Directors shall be elected as set forth in the By-Laws of the Corporation.
