## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator pursuant to Chapter 617 of the Florida Statutes, LORIDA adopts the following Articles of Incorporation:

#### ARTICLE

The name of the corporation shall be: Genora H. Kennedy Scholarship Fund, Inc.

## **ARTICLE II**

The principal place of business and the mailing address of this corporation shall be: 251 Pelican Drive, NE, Palm Bay, Florida 32907.

#### **ARTICLE III**

#### **Purpose**

The general purpose for which this corporation is formed is to operate exclusively for educational purposes which will qualify it as an exempt organization under Section 501(e)(3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax law, including, for those purposes, the making of distributions to organizations which qualify as tax exempt organizations under that code.

The specific purpose for which this corporation is formed is to provide monies to financially needy students to assist those students who may not otherwise attend college.

#### ARTICLETY

#### Manner of Election of Directors

The directors shall be members of the association, shall be elected annually at the annual meeting of the members and shall serve for a term of one (1) year or until their respective successors are elected and  $\epsilon_0$  and  $\epsilon_0$ .

#### ARTICLE V

#### Limitation of Corporation Powers

This corporation shall have and exercise all rights and powers conferred or unincorporated associations generally under the laws of the State of Florida. Provided however, that the corporation is not empowered to engage in any activity which is not itself in furtherance of its purpose as set forth previously.

No part of the net earnings, properties or assets of this association shall inure to the benefit of any private person or individual, or any member, officer or director of this corporation on a dissolution or otherwise. On liquidation or dissolution, all properties or assets of this association remaining after payment or provision for all debts and obligations shall be distributed and paid over to a fund, foundation or corporation organized and operated for charitable or religious purposes designated by the board of directors which, at the time qualifies as a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any subsequent federal tax laws.
