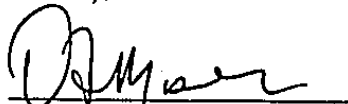

ARTICLES OF INCORPORATION
OF

The undersigned, acting as the sole incorporator, desiring to form a non-profit corporation pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. - NAME OF CORPORATION

The name of the corporation shall be THOMAS ENTERPRISES, SANFORD, FLORIDA, INCORPORATED.

ARTICLE II. - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE III - GENERAL PURPOSES

It is intended that the corporation is organized for and may conduct and transact any and all lawful business authorized for which non-profit corporations may be incorporated under the Florida General Corporation Act and/or permitted under the laws of the United States.
