ARTICLES OF INCORPORATION

FOR

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

ARTICLE II - Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be 1711 North University Drive, Plantation, FL 33322.

ARTICLE III - Purpose(s)

The specific purpose(s) for which the corporation is organized is (are): to organize and operate all church functions and activities including, but not limited to, regular meetings, care and instructions for the young. ***see attachment***

ARTICLE IV - Manner of election of directors

The manner in which the directors are elected or appointed shall be stated in the bylaws.

ATTACHMENT TO ARTICLE 111

- A. The purpose for which Restoration Fellowship Center, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Law.
- C. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V - Limitations of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

ARTICLE VI - Initial registered agent and street address
