ARTICLES OF INCORPORATION
OF
THANKFUL MISSIONARY BAPTIST CHURCH, INC.

ARTICLE 1
NAME AND ADDRESS

The name of this Corporation is: THANKFUL MISSIONARY BAPTIST CHURCH, INC. and it's corporate office is located at 16509 Brigadoon Dr., Tampa, Florida 33618.

ARTICLE 2
PURPOSE

The Corporation is organized exclusively for religious, charitable, and educational purposes in accordance with the laws of not-for-profit corporations of the State of Florida. The Corporation also shall operate in such a manner as to qualify as an exempt organization under Section 501 (C) (3) of Internal Revenue Code of 1986, as amended, or any corresponding provisions of any subsequent federal tax laws.

ARTICLE 3
POWERS

This Corporation shall have all powers granted to not-for-profit corporations by the statutes of the State of Florida.

ARTICLE 4
LIFE OF THE CORPORATION

This Corporation shall have perpetual existence unless dissolved by appropriate laws of the State of Florida in the manner set forth therein.

ARTICLE 5
QUALIFICATION OF MEMBERS

Persons may qualify as members of this Corporation by openly professing their faith in God and his son Jesus Christ; accepting the covenants of the Baptist church; receiving a positive vote into membership by the body of the church; and the payments of annual dues and special assessments.

**ARTICLE 6
POLICY MAKERS**

The Board of Directors shall be the policy makers of this Corporation. Members of the Board shall be elected for a term of one year at a duly constituted annual membership meeting. There shall be seven (7) members of the Board of Directors. At the first duly constituted meeting of the board of directors each year, the directors shall elect a president, vice-president, secretary, and treasurer from the elected members of the board.

**ARTICLE 7
BOARD AND OFFICERS**

The initial Board of Directors and Officers who will serve until the first regular election, and their names and addresses are as follows:

**ARTICLE 8
PROHIBITIONS**

No part of the net earnings of the Corporation shall accrue to the benefit of, or is distributable to the members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay

reasonable compensation for services rendered, and make payments, and disbursements in furtherance of the purposes set forth in these articles. Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (C) (3) of the Internal Revenue Code of 1986, as amended (or, the corresponding provisions of any future United States Internal Revenue law), or by a corporation, to which, contributions are deductible under Section 170 (C) (2) of the Internal Revenue Code of 1986 (or, the corresponding provisions of any future United States Internal Revenue law).

ARTICLE 9 DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payments of all of the liabilities of the Corporation, dispose of all the assets of the Corporation exclusively, to further the purposes of the Corporation in such a manner it deems reasonable, or distribute the net assets to such other organization, or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall, at the time, qualify as an exempt organization or organizations under Section 501 (C) (3) of the Internal Revenue Code of 1986, as amended (or, the corresponding provisions of any future United States Internal Revenue law), as the Board of Directors shall determine. Any such assets not so disposed shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes, or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such tax exempt purposes.

ARTICLE 10 REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation shall be 16509 Brigadoon Dr., Tampa, Fl 33618. Also, the initial registered agent of said Corporation shall be Aaron L. Carey.

ARTICLE 11 AMENDMENTS

Amendments to this charter are made by resolutions that have been passed by the Board of Directors, and are then adopted by two-third (2/3) of the members of the Corporation at a regular, or specially called membership meeting.

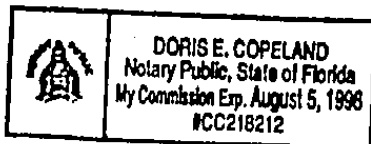

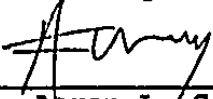
