The undersigned acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I: NAME

The name of the corporation is GFWC BAYSIDE WOMAN'S CLUB, INC.

ARTICLE II: DURATION

The period of its duration is perpetual.

ARTICLE III: PURPOSE

The purpose is to promote education, general welfare, civic development and participation in GFWC and FFWC projects.
