### ARTICLE III

1. To conduct classes and skills training leading to certification in Peace Education and Alternative Dispute Resolution methods. The classes will be available to professionals who work with Educational Institutions, Community Agencies, Corporations, Churches, Penal Institutions (juvenile/adult), Government Agencies, and Family Groups.
2. To host Peace Camps for children that will teach them Conflict Resolution skills and strategies, Anger management, Self Control, Self Efficacy, Problem Solving, and effective group living. The camps will be conducted by the Institute staff and will be held in durations of one day to one week.
3. To host Peace Retreats and Workshops for Couples, and Families that will focus on domestic violence, communication skills and handling conflict in the home. The retreats will be conducted by Institute staff persons who are experts in the fields of conflict resolution and marriage and family therapy.
4. The Research department of the Institute will collect and evaluate data to measure the effectiveness of these interventions for violence reduction. Research findings will be made available to government and other organizations through publication.
