



The undersigned, in accordance with the provisions of Section 617, Florida Statues, hereby make, subscribe and file these Articles of Incorporation for the purpose of forming a corporation not-for-profit

#### **ARTICLE I: NAME**

The name of the corporation shall be: Florida Institute for Peace Education and Research, Inc.

#### ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 521 E. Las Olas Blvd, Ft. Lauderdale, FL 33301.

#### ARTICLE III: PURPOSE(S)

The purpose and objects for which this Corporation is organized and the general nature of the business to be transacted shall be to:

- Conduct classes and skills training leading to certification in Peace Education and Alternative Dispute Resolution methods. The classes will be available to professionals who work with educational institutions, community agencies, corporations, churches, penal institutions (juvenile/adult), government Agencies, and family groups.
- 2. Host Peace Camps for children that will teach conflict resolution skills and strategies, anger management, self-control, self-efficacy, problem-solving, and effective group living. The camps will be conducted by the Institute staff and will be held in durations of one day to one week.
- 3. Host Peace Retreats and Workshops for Couples and Families that will focus on domestic violence, communication skills and

handling conflict in the home. These retreats will be conducted by Institute staff or outside professional experts in the fields of conflict resolution and marriage and family therapy.

- 4. Conduct research, collect and evaluate data to measure the effectiveness of Institute interventions. Research findings will be disseminated to government and other relevant organizations through final reports, newsletters, research action notes, and other publications as relevant.
- 5. Said corporation/organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations under section 501(c) (3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code)

### ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are elected or appointed is stated in bylaws.

### ARTICLE V: LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

No part of the net earnings of the corporation/organization shall inure to the benefit or, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c) (3) purposes. No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation/organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Upon the dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

The Florida Institute for Peace Education and Research is a non-profit, non-stock corporation.
