CORPORATE ARTICLES FOR A NOT FOR PROFIT CORPORATION**

The undersigned, a subscriber to these articles of incorporation, a natural person competent to contract, hereby presents these articles for the formation of a corporation pursuant to the laws of Florida.

1. The name of the corporation shall be UNITED STATES BONE MARROW ASSOCIATION INC.
2. The corporation may engage in any lawful business activity permitted under the laws of the State of Florida or purposes not for pecuniary profit. The specific purpose for which the corporation is organized is to administer a bone marrow registry.
3. The initial address of the registered office and the name of the registered agent shall Eduardo Gutierrez at 130 Ponce De Leon Blvd. Coral Gables, Fl 33135. The board of directors shall from time to time move the office of the registered agent to any address in Florida. The principal address of the corporation is 130 Ponce De Leon Blvd. Coral Gables, Fl 33135 and the registered office of the corporation is the same.

4. Initially the corporation shall have three directors which are appointed. The method of election and the number of directors, which shall be increased or diminished from time to time, shall be stated in the by-laws of the corporation.

5. The amount of capital with which the corporation shall begin business shall not be less than five hundred dollars.

6. The corporation shall exist perpetually.

7. The name and address of the first board of directors, who shall serve and with the first election, are:

- a. Eduardo Gutierrez 130 Ponce De Leon Blvd. Coral Gables, Fl 33135
- b. Estaban Barrios 130 Ponce De Leon Blvd. Coral Gables, Fl 33135

8. The affairs of the Corporation are to be managed by a President, one Secretary and a Treasurer. Such officers shall be elected annually on the first Monday of every January. The By-laws of the Corporation shall include the manner in which directors are elected. The names of the persons who are to serve as officers until the first election of officers, the Articles of Incorporation are as follows:

9. The corporation shall have members who will be required to meet the following qualifications, people or organizations who will seek bone marrow donations for bone marrow registries.

10. The Bylaws of the Corporation are to be made, altered or rescinded by a majority of the members of the corporation.

12. These articles of incorporation may be amended in any manner provided by law. Every amendment shall be approved by the board of directors, proposed to them by the members and approved at a Members' meeting by a majority of shares entitled to vote thereon.
