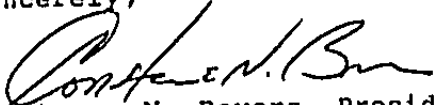

**ARTICLES OF INCORPORATION**

*The undersigned, acting as incorporate(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

**ARTICLE I**

**Name**

The name of the corporation shall be **God's Generation, Inc.**

**ARTICLE II**

**Principal Place of Business and Mailing Address**

The principal place of business and mailing address of this corporation shall be 16820 S W 109 Avenue, Miami, Florida, 33157.

**ARTICLE III**

**Purpose(s)**

The Corporation is organized as a not- for-profit, charitable corporation and not for the private or pecuniary gain of any person or entity. The specific purposes for which the corporation is organized are:

To operate exclusively for charitable and educational purposes, including , without limitation, for the relief of youths, to assists such persons to become self-sufficient and self-reliant. In order to effect the foregoing, the corporation shall, among other things, assist those individuals through counseling, training and education.

**ARTICLE IV**

**Manner of Election**

The affairs of the corporation shall be managed by a board of directors. The number of directors comprising the board and the manner in which such directors shall be elected shall be set forth in the Corporation's By-Laws.

## ARTICLE V

### Limitation of corporate powers

1. No director or officer of the corporation shall be personally liable to the corporation or any other person or entity for monetary damages for any statement, vote, decision, action or inaction by any director or officer regarding the corporation's management or policies, except as set forth in Section 617.0302, Florida Statutes, (as it may be amended or superseded).
2. The Corporation shall have the power, only to the extent that its status as an organization exempt from federal income taxation under Section 501 ( c ) ( 3 ) of the Code (as it may be amended or superseded) is not affected or prejudiced in any way, indemnify and/or advance expenses to any person who was or is a director, officer, employee or agent of the corporation (or was or in which the corporation had or has a direct or indirect interest) for any and all liability, cost or expense incurred by such a person in connection with any claim, action or proceeding to which such person is party by reason of holding any such position with the Corporation.

## ARTICLE VI

### Initial Registered Agent

The initial address of the Corporation's registered agent is the office of *Connie Bowers and Associates, Inc.*, located at 16938 South Dixie Highway, Miami, Fl. 33157. The name of the registered agent is Constance N. Bowers, President.

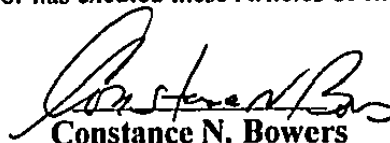

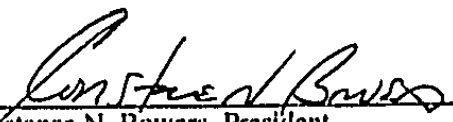
