ARTICLES OF INCORPORATION
OF
TRUE VINE OUTREACH MINISTRY, INC.
A Corporation Not For Profit

We, the undersigned, do hereby associate ourselves together for the purpose of forming a religious, non-profit Christian organization being incorporated under the Laws of the State of Florida applicable to corporations not for profit, and hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation is:

TRUE VINE OUTREACH MINISTRY, INC.

ARTICLE II
NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to propagate the Gospel of Jesus Christ in word and in deed, and to train the members of this organization for the work of the ministry, and the objects and purposes proposed to be promoted and carried on by this corporation are to do any and all of the things set forth as fully and to the same extent as natural persons might or could do in any part of the world, not for profit, as follows: The general nature of the objects of the church shall be religious, christian, charitable and such other as are generally carried on by religious christian organizations in the United States; to train, license, and conduct such church departments, or agencies and schools as may be proper to the above mentioned purposes; to own, control, lease and purchase and to take by gift, devise, bequest, or otherwise, and to convey, dispose of, mortgage, encumber, lease, and in every respect to do all things and exercise all powers which a natural person might do and exercise over and about real or personal property of every nature and kind whatsoever, including real estate, leaseholds, bonds, stocks and securities wherever the same may be situated or located; to maintain offices, headquarters, building or other facilities for accomplishing the objects of the corporation; to issue bonds, promissory notes, securities, and agreements for, or evidence of, indebtedness of every character, and to mortgage, pledge, or otherwise encumber property; to contract in or about properties, monies, funds or other subject matters of every character and kind whatsoever, and to do everything else which a natural person could do incident to, or convenient in connection with the objects of the corporation; to sue and defend suits in its corporate name.

**ARTICLES III
CAPITAL STOCK**

This corporation shall have no capital stock.

**ARTICLE IV
QUALIFICATIONS OF MEMBERSHIP**

The qualifications for members and the manner of their admission shall be as governed by the by-laws of this corporation.

**ARTICLES V
TERM OF EXISTENCE**

This corporation is to have perpetual existence.

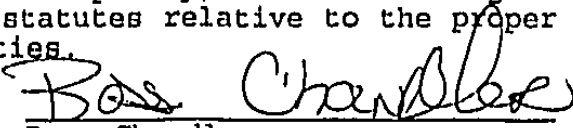
