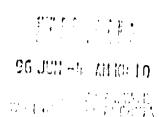

#### Articles of Incorporation

FLORIDA PERSIMMON GROWERS ASSOCIATION, INC.

The undersigned hereby incorporate pursuant to Chapter 617, Florida Statutes, as follows:

#### I. NAME

The name of the corporation shall be FLORIDA PERSIMMON GROWERS ASSOCIATION, INC.

### II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

# III. INITIAL PRINCIPAL OFFICE

The initial principal office of the corporation is 23950 N.E. 135th Avenue Rd., (P.O. Box 183), Orange Springs, FL 32182.

#### IV. PURPOSE

This corporation is organized for the purpose of promoting the growing and marketing of persimmons in Florida, including, but not limited to, research, development, and education regarding propagation, cultivation, harvesting, packaging, marketing and advertising. It is intended that this be a cooperative endeavor involving all persimmon growers that choose to be members.

#### V. DIRECTORS

The number of Directors of the corporation shall be provided in the Bylaws of the corporation. The directors shall be elected by the members at the annual meeting.

Directors may be elected for one year terms or staggered

torms of not more than three years as provided in the Bylaws, and shall serve until their successor is elected.

## VI. CONDUCT OF BUSINESS

In furtherance and not in limitation of the powers conferred by statutes, the following specific provisions are made for the regulation of the business and the conduct of the affairs of the corporation.

- (a) Subject to such restrictions, if any, as are herein expressed and such further restrictions, if any, as may be set forth in the Bylaws, the board of directors shall have the general management and control of the business and may exercise all of the powers of the corporation except such as may be by statute, or by the Articles of Incorporation or amendment thereto, or by the Bylaws as constituted from time to time, expressly conferred upon or reserved to the stockholders.
- (b) The corporation shall have such officers as may from time to time be provided in the Bylaws and such officers shall be designated in such manner and shall hold their offices for such time and shall have such powers and duties as may be prescribed by the Bylaws, or as may be determined from time to time by the Board of Directors subject to the Bylaws.

#### VII. POWERS

This corporation shall have the power to do any act generally permitted to corporations under the laws of Florida.

# VIII. REGISTERED OFFICE AND REGISTERED AGENT

#### XI. MEMDERS

Any person who grows persimmons or who intends to grow persimmons in Florida, and who pays the annual membership dues provided by the bylaws, may be a member of the corporation. The bylaws may provide for difference classes of members with a different annual membership for each class and different voting rights for each class.

# XII. EXEMPT PURPOSE

This corporation is organized exclusively for public purposes as a not-for-profit corporation within the meaning of Section 501(c)(5) of the Internal Revenue Code, and its activities shall be conducted for such purposes and in such a manner that no part of its direct earnings shall inure to the benefit of any member, director, officer or individual. In addition, the corporation shall be authorized to exercise the powers permitted non-profit corporations under Chapter 617, Florida Statutes; provided, however, that the corporation in exercising any one or more powers shall do so in furtherance of the exempt purpose for which it has been organized as described in Section 501(c)(5) of the Internal Revenue Code or any amendments or additions thereto.

# XIII. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a

stockholders' meeting by a majority of the stock entitled to vote thereon, unless all the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

# XIV. DISSOLUTION

Upon dissolution of this corporation all of its assets romaining after the payment of all costs and expenses of such dissolution, shall be distributed to the Institute of Food and Agricultural Sciences at the University of Florida, or an organization which is qualified for exemption under Section 501(c)(5) of the Internal Revenue Code for the same or similar purpose as this corporation, and none of the assets will be distributed to any member, officer or director of the corporation.
