ARTICLES OF INCORPORATION
OF
IMPACT MINISTRIES INTERNATIONAL, INC.

ARTICLE I - NAME

The name of this Corporation is Impact Ministries International, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purposes for which the corporation is organized are:

A. To minister the Gospel and to receive and administer funds and to operate exclusively for charitable, religious, scientific, literary or educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 (or comparable provisions of subsequent legislation).

B. To acquire, own, purchase, lease, dispose of and deal with real and personal property and interests either absolutely or in trust therein and to apply gifts, grants, bequests and devises and the proceeds thereof in furtherance of the purpose of the corporation.

C. To do such things and to perform such acts to accomplish its purposes as the Board of Trustees may determine to be appropriate and as are not forbidden by Section 501 (c)(3) of the Internal Revenue Code of 1986, with all of the power conferred on nonprofit corporations under the laws of the State of Florida.

Without limiting the foregoing, the express purpose of this corporation is to preach, spread and promote the Gospel of Jesus of Nazareth by proclaiming the Word of God, the Holy Bible, both Old

Testament and New Testament in every means known to, or to be made known to man for eternal healing, deliverance and prosperity of all who will believe in Jesus of Nazareth.

ARTICLE IV - QUALIFICATION OF MEMBERS

The authorized number and qualification of members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting and other rights and privileges of members and their liability for dues and assessments and the method of collection thereof, shall be set forth in the by-laws.

ARTICLE VI - BOARD OF TRUSTEES

- Section 1. All corporate powers shall be exercised by or under the authority of, and the affairs of the corporation shall be managed under the direction of, the Board of Trustees.
- Section 2. The number of Trustees shall be determined from time to time in accordance with the bylaws, but shall never be less than three Trustees, and, in the absence of any such determination, shall be three Trustees.
- Section 3. The Trustees shall be elected or removed in accordance with the procedure provided in the by-laws.
- Section 4. The names and addresses of the persons who are to serve as initial Trustees until the first annual meeting of members and until their successor has been elected and qualified are as follows:

ARTICLE VII - BY-LAWS

Subject to the limitations contained in the by-laws and any limitations set forth in Chapter 617, Florida Statutes, concerning corporate action that must be authorized or approved by the Membership of the Corporation, the by-laws of this Corporation may be made, altered, rescinded, added to, or new by-laws may be adopted, either by a resolution of the Board of Directors or by a procedure set forth in the by-laws of the Corporation.

ARTICLE VIII - AMENDMENTS

These Articles of Incorporation may be amended in the manner provided by Chapter 617 Florida Statutes, or as subsequently amended.

ARTICLE IX - LOCATION PRINCIPAL OFFICE

The street address of the Corporation's initial registered office shall be:

and the name of its initial Registered Agent at such address shall be: JAMES L. LEE

ARTICLE X - NON-PROFIT SHARE

The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal

Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Code.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. This Corporation shall be authorized to exercise the powers permitted non-profit corporations under Chapter 617 of the Florida Statutes; provided, however, that this Corporation in exercising any one or more of such powers shall do so in furtherance of the exempt purpose for which it has been organized as described in Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, nor shall the corporation participate in or intervene in any political campaign on behalf (or in opposition to) any candidate for public office.

ARTICLE XI - DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a State or local Government, for a public purpose, and none of the assets will be distributed to any member, officer, or trustee of this

organization. Any of such assets not so disposed of shall be disposed of by the Circuit Court of the Fifth Judicial Circuit of Florida, in and for Marion County, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

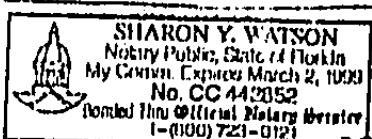
