The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, heroby form a corporation not for profit, under Chapter 617, Florida Statutes, and do hereby certify that it has become such corporation under and pursuant to the following Articles of Incorporation.

ARTICLE I

The name of the corporation is "BIBLE BRETHREN FELLOWSHIP, INC." and the initial principal address of the corporation is Route 3B, Box 615, Port St. Joe, Florida 32456.

ARTICLE II

The period of the duration of this corporation is perpetual and is dissolved according to law.

ARTICLE III

This corporation is organized exclusively for religious and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law or to the Federal, State or Local government for exclusive public purpose.

The specific purpose of BIBLE BRETHREN FELLOWSHIP, INC.
is to preach the gospel of Jesus Christ.

ARTICLE IV

The qualifications for membership and the manners of
their admission are set forth in the By-Laws of this corporation.

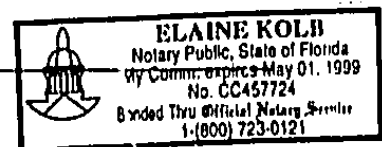

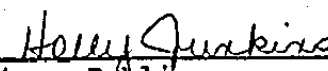
