ARTICLES OF INCORPORATION  
OF  
THE CENTER FOR EDUCATION AND ARTS, INC.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation shall be:

THE CENTER FOR EDUCATION AND ARTS, INC.

ARTICLE TWO

The address of the principal office of the corporation is:

ARTICLE THREE

The specific purposes for which the corporation is organized are:

The primary educational function of the center will be to provide basic skills remediation to youth and adults with the intent of supplementing programs currently in place within the local educational system, (eg. GED for adults). The center will work in tandem with parents of youth and school guidance professionals in prescribing a course of remediation. Remediation will be effected through the use of Computer Aided Instruction (CAI) and one-on-one tutoring. The center will also operate a Homework Hotline as a community service available to Middle and High Schools in the vicinity of the center.

The primary arts function of the center will be to expose youth to activities and opportunities that are available to them in the areas of music, drama and creative arts. These activities will be tied to academic achievement and used to enhance the overall performance of the student.

Youth will be given the opportunity to participate in school to work activities as described in the Secretaries Council on Achieving Necessary Skills (SCANS) such as apprenticeships and mentoring programs with area businesses.


