ARTICLES OF INCORPORATION OF WESTSIDE AFRICAN AMERICAN HOMEOWNERS AND HOMESTEADERS ASSOCIATION, Inc.

We, the undersigned, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the laws of the State of Florida, in accordance with the provisions of Chapter 617, Florida Statutes and further adopt the following Articles of Incorporation:

ARTICLE I Name

To further the economical development and social welfare of the community. And when necessary, act as liaison between residents and local, county and state government.
