CERTIFICATE OF INCORPORATION

OF

BASS DILLARD NEIGHBORHOOD ISSUES AND PREVENTION, INC.

A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporator of a not for profit corporation under the Fiorida Not For Profit Corporation Act, as set forth in Chapter 617 of the Fiorida Statutes, is amended, adopts the following Articles of Incorporation for such Corporation:

APTICLE I: NAME

The name of the Corporation shall be: PASS DILLARD NEIGHBORHOOD ISSUES AND PREVENTION, INC., hereinafter referred to as the "Corporation".

APTICLE III PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the Corporation is and the muiling address of the Corporation is 1750 North-west 24th Terrace, Fort lauderdale, Storida 33311.

ARCICLE TITE ITERATION

The period of duration of the Corporation shall be perpetual urless discolved according to law.

APPLICATION IV: PURPOSES

for charitable and educational purposes, including plans of action to address adverse impact on neighborhood life within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501 (c)(3)) of the Internal Revenue Code of 1986, (or the corresponding provision of any future United States Internal Revenue Law), or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of any future United States Internal Revenue Law).

APPICLE V: PESTFICTIONS ON ACTIVITIES

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE VI: MEMBERSHIP

The Corporation shall be a membership organization.

ARTICLE VIII REGISTERED OFFICE AND AGENT

The Corporation's registered office shall be located at 1750 NW 24 Terrace Fort Lauderdale, Florida 33311 and LFOLA R. McCOY is the registered agent of the Corporation at that address.

ARTI JE VIII: BOARD OF DIRECTORS

The initial Board of Directors shall consist of fifthteen (15) persons. The number of directors may be increased or decreased from time to time by an amendment to the bylaws; however there shall never be less than three directors. All directors shall be selected as provided for in the bylaws.
