ARTICLES OF INCORPORATION

East Orlando Community Church, Inc.

MLLAMASSICATLORIOA The undersigned, acting as incorporator of a corporation pursuant to chapte Florida Statutes, adopts the following Articles of Incorporation:

ARTICLET

Name

The name of this corporation shall be East Orlando Community Church, Inc.

ARTICLE II

Principal place of business and mailing address The principal place of business and mailing address of this corporation shall be 3588 Foxcroft Circle, Oviedo, FL 32765.

ARTICLE HI

Purposes

The general purposes for which this corporation is organized are:

- (1) To preach the Gospel, to administer the ordinances of the New Testament, to minister to the spiritual needs of its attenders and members and of all people everywhere, to gather people for worship of the living God, to train Christian workers for Christian work, and to advance the evangelization of the world by winning people to a dynamic faith in Jesus Christ.
- (2) To take, secure, accept, hold, or acquire by gift, purchase, legacy, or otherwise, real and personal property, whenever it deem the same proper, necessary, and expedient in the work and purposes for which this body was organized and incorporated; and to hold, lease, incumber, give, exchange, or sell and transfer and dispose of the same, in part or in whole, when it deems such action expedient, necessary, or beneficial in promoting and advancing the work and purposes for which this corporation is formed; and to do or accomplish such acts as this body shall deem necessary or incidental thereto; all such acts to conform to the laws of this state.

ARTICLE IV

Manner of appointment of directors

The directors of this corporation shall be appointed in the manner stated in the bylaws of this corporation.

ARTICLE V

Limitation of corporate powers

No part of the net earnings of the church shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to gay reasonable compensation for services rendered and to make payment and distributions in furtherance of the

purposes set forth in Artricle III thereof. Upon dissolution of the corporation, the Board of Directors shall, after paying and making pravisions for the payment of all of the assets of the corporation in such manner, or to such organization of organizations organized and operated exclusively for charitable education and religious purposes, as shall at the time qualify as an exempt organization or organizations under Section 501(c) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) as the the Board of Directors shall determine.

ARTICLE VI
