DISPOSITION OF ASSETS






BYLAWS AMENDMENTS


The power to adopt, alter, amend or repeal the Bylaws of the Corporation shall be vested in the directors in accordance with the provision of the Bylaws.



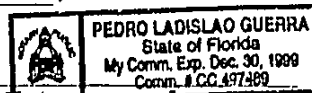
