The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617,
Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be OPEN DOOR BAPTIST MISSION,^{INC.} and the
proposed place of business shall be P. O. Box # 7000846 , St. Cloud, Florida 34770.

ARTICLE II

The period of the duration of this corporation shall be perpetual, unless dissolved
according to law.

ARTICLE III

The purpose for which the corporation is organized is as follows:

To operate a Christian Church and to conduct such other business as may
reasonably be related to said operation.

ARTICLE IV

The qualifications for members are that they must be born again Christians.

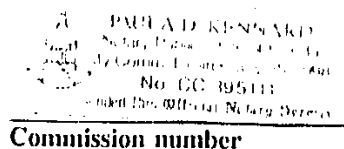
